Lot 20 Cole Road for sale

In 2020 the WAPC agreed to transfer Lot 2 Great Eastern Hwy, Lot 2083 & Part Lot 2348 Cole Road, Lots 10 & 108 Pearce Street, Sawyers Valley from the Rural Residential zone to the Development zone in LPS 4.

Lot2, Lot 2083 and part Lot 2348 were advertised for sale on 16th June 2021 as number 20 Cole Road, Sawyers Valley. Please keep an eye out on the SVRRA website and Facebook page for further updates.

Concerns with this development include fire escape routes, effluent disposal issues and potential high dwelling densities.

Highway Noise by Trucks

The issue of noise is being revisited by the SVRRA. This relates to truck noise as vehicles slow down into Sawyers Valley from the east.

They pass an 80km sign at the top of the rise and then are going downhill and slowing to 60km. This generates a lot of engine brake noise. The suggested solution is to move the 60km sign east to near Cairn Road. The 80km sign would be back near Lion Street. The trucks would already then be at 60km at the top of the rise so less noise will emanate as they go downhill to the townsite.
