Any Other Business

North Stoneville postponed again.

An article from the Echo, 18th March 2022 was tabled. It outlined concern expressed by the Save Perth Hills group that they are not allowed to participate in private mediation between the State Administrative Tribunal (SAT) and the developers. Their concern also goes to the private nature of the meetings between bureaucrats and a profit-driven developer. A petition against this mediation has over 1,000 signatures.

A motion was moved at the Mundaring Shires Annual Electors Meeting for the Shire to formalise its recognition of Save Perth Hills as a volunteer community group. This will be considered by councillors at a future council meeting.

Maintenance Issues for Shire of Mundaring attention

Concern was raised that a roadside drain near 1065 Railway Terrace in Sawyers Valley needing to be cleared of leaves/litter. Due to the build-up of material, storm water is unable to flow freely off the road. P. Benson will send a photo of the drain to M. Le Vaux.

It was noted that one of the male toilets in the Sawyers Valley Hall is flowing all the time.

At the south end of Sexton St a series of rocks were placed to stop vehicle access onto the Heritage walk trail. These rocks have been moved. It is thought to have been done to allow Telstra access. They have not been replaced and vehicles have been seen parked on the walk trail recently.

The Shire will be informed of these issues for their attention.

Gravel Road joining Helena Terrace and Railway Terrace

This road which is crossed by the Heritage Trail is made of gravel. Gravel is frequently spreading onto Railway Terrace requiring constant sweeping. The meeting resolve to approach the Shire regarding bituminising this section. The Shire has been reluctant to do this in the past due to it not being an official road.

Updates to photos at the Sawyers Valley Hall

The meeting was informed of the recent upgrade of historical photos in display cabinets at the Sawyers Valley hall. The existing ones, which are many years old, were badly faded. Jenny Schwagereit has replaced them with better quality photos she was able to locate. She has also added extra photographs.

The meeting was also informed of the "Old Sawyers Valley" Facebook page containing historical photos of Sawyers Valley.

Mention was made of a letter to the SVRRA regarding the free app called "Nextdoor Sawyers Valley". The app connects local residents to recover lost pets, find free stuff, sell an old bike, borrow a ladder, hire a recommended tradie etc. The website is nextdoor.com.au.

Next Meeting Date

A request was made to move the next meeting dates from the first Monday in August to the last Monday in July. This is 25th July 2022. The meeting agreed to this move. The Secretary will contact the shire regarding the date change and advise members.
