Matters Arising from the Minutes

North Stoneville

A link on the Sawyers Valley website has been added to a survey the Save Perth Hills are conducting. The petition is asking the WA State Government to follow recommendation 5 in the 2021 Woorooloo Bushfire report. It means that DFES advice be followed, when it comes to planning.

Maintenance Issues for the Shire of Mundaring attention

The meeting noted that the Shire has carried out maintenance on the drainage sump we wrote about. In addition, they have cleared the roadside spoon drains and other drainage sumps along Railway Terrace.

The rocks at the end of Sexton Street stopping vehicles from accessing the walk trail have been restored.

Grevillea Park

Adriaan has received no further information on the Grevillea Park to report. He did advise that there are two access roads to the subject area. One via Millstream and the other from Fagan St east of Stonehouse. There is no timeline for the project as it's dependent on the outcome of the Royal Commission into Defence and Veteran Suicides. The hearings in Perth are scheduled for May 2023.

It was mentioned that much of the site for this park was an old gravel quarry. Links have been put on the SVRRA website to more information on Grevillea Park.

Any Other Business

National Recycling Week

The meeting discussed recycling, sparked by the advert in today's The West Australian for National Recycling Week. The picture showed 10c refundable bottles being put into recycling, which could suggest this was the correct thing to do. The meeting discussed how complex the recycling rules are and the ease with which incorrect sorting can result in contamination. More education is needed on correct recycling.

Consideration to Windup the SVRRA

A number of years ago a meeting of the ratepayers discussed winding up the association due to low community interest. It was decided to continue operations.

The issue was raised for reconsideration this month. The existing committee has been in place for a number of years and our membership has not grown. Some issues pursued by the SVRRA have garnered little interest from residents affected. The existence of COVID has made meetings and participation more difficult.

The committee is at the point where the withdrawal of any member would make it unworkable.

The meeting resolved to map out what steps would be required to windup the association rather than wait to have to do it under stressed conditions.

The ability to grow the association relies on heavier Social Media engagement.

Actions to windup the association will be considered at the February 2023 meeting. The Secretary and President will investigate the steps required. The next AGM in May 2023 is expected to see the committee retire which could initiate its windup.
